These selections support the <u>Certified Information Privacy Professional/Europe (CIPP/E)</u> credentialing program which assesses candidates' understanding of information privacy laws and practices that apply primarily to the European private sector.

Resource Breakdown:

- The **primary** resource is the official IAPP textbook that encompasses the content referenced in the Body of Knowledge (BoK). While the IAPP does not draw from a single source to develop exams, this is the main text that supports the program.
- The supplemental resources are other notable sources that may focus on specific areas of the Body of Knowledge; therefore, the IAPP strongly suggests that you incorporate supplemental reading into your regimen for exam preparation based on your individual needs.
